

Good Day!

We, the farmers of Mt. Canatuan Tabayo Siocon, Zamboanga del Norte, are requesting your help because we are being evicted by TVI from our homes, our farmlands, and our livelihoods. Their open pit mining operations have affected our plants and our community.

Attached here is the copy of the TVI eviction notice in which the company gives us 15 days to leave our land.

We planted 2,000 rubber trees, banana trees, coconut trees, mahogany, various fruit trees and other trees. With all of these, we will be losing more than p 436,000 monthly if TVI ousts us from our homes. We have nowhere else to go.

The people of Canatuan are urgently requesting your help Governor. We hope that you will help us.
